**PARTICULARS OF THE POST**

**Member of the District Consumer Disputes Redressal Forum**  
**under the Consumer Protection Act, 1986**

1. The work consists of writing judgements after hearing the cases along with other Members.
2. The appointment will be for five years or till the member reaches the age of 65, whichever is earlier.
3. The appointment will be on full time basis and the incumbent will receive a consolidated honorarium of Rs.15,000/- per month.
4. The person should be of ability, integrity and standing, and have adequate knowledge or experience of or have shown capacity in dealing with, problems relating to Law, Economics, Commerce, Accountancy, Industry, Public affairs or Administration, Education, Science or any other branch.
5. Before appointment, he/she shall have to give an undertaking that he/she does not and will not have any such financial or other interests as are likely to affect prejudicially his/her functions as a Member.
