The bidders may take note of the following amendments

- a) **Wherever the wordings Single Boiled Rice appears in the entire tender document containing 34 pages including top 2 pages unnumbered, which should be read as;**

“White Colour Single Boiled Rice”

- b) **Wherever the wordings “like ADT-39/Chinna Ponni, etc., appears in the entire tender document containing 32 pages, which should be read as;**

“like ADT-36,ADT-38, ADT-39, ADT-43,ADT 45, CHINNA PONNI, PUDUVAI PONNI,CO-43, CO-45, ASD-16, ASD-18, SORNA and such other fine variety or equal fine quality rice but not bold variety”

- c) **In the Tender Notification at page 2 of 32, under the Sl. No.2 “Tender Schedule” the name of the Component should be read as follows;**

Quality white colour Single Boiled Rice of common grade (strictly free from stones, iron particles, broken rice, husk, bran, black rice, discoloured, damaged, unpolished rice, any other organic and inorganic foreign particles).

- d) **Clause 1 of Eligibility Condition at page 5 of 32 shall be read as:**

1. The tenderer, in case of rice millers, shall have an average monthly turnover of minimum Rs.3 Crores in rice trade during any of the last three years and in case of other than Rice Millers, the monthly turnover of minimum of Rs.3 Crores in overall trade including rice during any of the last three financial years. The tenderer other than Rice Miller shall be capable of trading the specified rice and required quantity. In this regard, a turn over certificate as per Annexure- IV and Balance Sheet and Profit & Loss Account along with Auditor’s Report are required to be submitted.

- e) **Clause 8 of Eligibility Condition at page 5 of 32 shall be read as:**

The tenderer should furnish an undertaking of self certification on quality of his rice.

f) Clause 1(f) of the General Terms and Conditions at page 6 of 32 shall be read as;

“Tenderer should submit 3 sample packets of half-a-Kg. (1/2 Kg.) white colour Single Boiled Rice of common grade of variety like ADT-36,ADT-38, ADT-39, ADT-43,ADT 45, CHINNA PONNI, PUDUVAI PONNI,CO-43, CO-45, ASD-16, ASD-18, SORNA and such other fine variety or equal fine quality rice but not bold variety” in sealed covers, strictly free from stones, iron particles, broken rice, husk, bran, black rice, dis-coloured, damaged, unpolished rice, any other organic and inorganic foreign particles” .

g) Clause 4 (a) (i), (ii) and (c) of RATE OFFERED at page 8 of 32 shall be read as follows;

4. RATE OFFERED

a) The rate shall be quoted per Kg. for both

i) supply of 10 Kg. rice (net weight) in bags (bags will be provided by PAPSCO) with stitching charges and

ii) for supply of 50 Kg. (net weight) rice in Polypropylene(PP) bags (PP bag of the supplier) inclusive of cost of PP bag;

and the rates are inclusive of packing charges, all Duties, Cess, VAT and any other statutory taxes as applicable, all expenditures of loading charges at their point, transportation to the specified Fair Price Shops or any other places/units specified by PAPSCO at Puducherry and Karaikal regions, transit insurance and unloading charges, etc. at and upto the specified places.

c) Based on the rates received, PAPSCO reserves the right to select either i) supply of 10 Kg. rice (net weight) in bags (bags will be provided by PAPSCO) with stitching charges and ii) for supply of 50 Kg. (net weight) rice in PP bags (PP bags of supplier) (or) both, as the case may be, according to its requirement and award supply contract to one or more bidders and the same would be final and binding on all the bidders.

h) Clause 8 (d) of SECURITY DEPOSIT at page 12 of 32 shall be read as follows;

In case of the successful tenderer fails to supply the ordered quantity in full/partially, the Security Deposit stands forfeited/Bank Guarantee will be invoked and the tenderer will be blacklisted.

i) Clause 10 (a) of SPECIFICATIONS at page 13 of 32 shall be read as follows;

Only good quality white colour SINGLE BOILED RICE of common grade of varieties like ADT-36,ADT-38, ADT-39, ADT-43,ADT 45, CHINNA PONNI, PUDUVAI PONNI,CO-43, CO-45, ASD-16, ASD-18, SORNA and such other fine variety or equal fine quality rice but not bold variety” strictly free from stones, iron particles, broken rice, husk, bran, black rice, dis-coloured, damaged, unpolished rice, any other organic and inorganic foreign particles only will be accepted.

j) Clause 11 (a), (b) and (c) of PACKINGS at page 13 of 32 shall be read as follows;

11. PACKING:

- a) Based on the selection of the tender for (i) supply of 10 Kg. (net weight) rice in bags (bags will be provided by PAPSCO) with stitching charges and (ii) for supply of 50 Kg.(net weight) of rice in PP bag as stated in Sl. No.4(c), the packing should be undertaken.
- b) In case of supply in 10 Kg. (net weight) bags (bags provided by PAPSCO);
- i) the 10Kg. rice should be kept compactly and stitched in good manner without giving way to pilferage, damage of the bags till the specified delivery places. In case of any damage/loss of bag/rice, PAPSCO reserves every right to deduct necessary amount from the payments to be made to the supplier or to cancel the agreement and forfeit the Security Deposit/invoke Bank Guarantee besides black listing the tenderer.
- ii) The bags should be only of PAPSCO bag and the labelling any on the bag should be as provided by PAPSCO and not of the bidder or other third parties. In case of any deviation in this regard, the Security Deposit of the tenderer will be forfeited besides blacklisting and the tenderer is only responsible for any consequences arising out the deviation.
- c) In case of supply of rice 50 Kg.(net weight) in PP bags (PP bags of supplier);
- (i) the Stocks should be delivered in new Polypropylene bags of 50 Kg capacity with inner polyethylene lining with machine stitched conforming to the packaging rules.
- (ii) Net weight of stock packed should be 50 Kgs. in standardized Polypropylene bag. The tare weight for the Single Boiled Rice of 50 Kg. new Polypropylene empty bag shall be considered 160 grams per bag.

k) Clause 12 of DURATION AND PLACE OF DELIVERY at page 14 of 32 shall be read as follows;

The supplier should start the supply of the ordered quantity of white colour Single Boiled Rice within 3 days as per specification prescribed and complete delivery should be made within 15 working days at the specified places of M/s. PAPSCO at the respective region viz., Fair Price Shops or any other place/unit from the date of supply order issued by the Corporation at the agreed rate including transportation and other expenditure.

l) Clause 14 (a) of ACCEPTANCE OF STOCKS at page 15 of 32 shall be read as follows;

Only the white colour SINGLE BOILED RICE of common grade of such variety selected in the tender only will be accepted. The stock should be free from stones, iron particles, broken rice, husk, bran, black rice, dis-coloured, damaged and unpolished rice, any other organic and inorganic foreign particles.

m) The last sentence in clause 14 (c) of ACCEPTANCE OF STOCKS “The decision of the Quality Control Team/authorized representative at loading points will be final and should not be disputed” shall be read as follows;

“The decision of the Quality Control Team/authorized representative at loading/[goods in transit/unloading points](#) will be final and should not be disputed”

n) Clause 15 (c) of PENALTY ON DEFAULT/EXTENSION OF TIME at page 16 of 32 shall be read as follows;

Supply of stock less than the ordered quantity is not permitted. If the ordered quantity is not supplied in full, the Security Deposit will be forfeited/[Bank Guarantee will be invoked](#) besides blacklisting.

o) the first para In Annexure-I : TECHNICAL UNDERTAKING at page 23 of 32 shall be read as follows;

I/We have clearly understood all the terms and conditions of the tender and agreement etc. and agree to undertake the supply of [white colour](#) Single Boiled Rice of common [grade of selected variety or the variety specified by PAPSCO during the period, which was mentioned by me and at](#) the rate quoted by me/us at the destinations specified by Corporation. The quality of the rice is assured and [free from stones, iron particles, broken rice, dis-coloured, damaged and unpolished rice, husk, bran, black rice, any other organic and inorganic foreign particles.](#)

p) condition 12 of Annexure-I at page 24 of 32 shall be read as follows;

[12\) An undertaking of self certification of quality of rice.](#)

q) first para of PART-II OF PRICE BID at page 26 of 32 shall be read as follows;

The Price bid should be quoted for per Kg. separately both for supply of;

- i) 10 Kg. [\(net weight\)](#) white colour Single Boiled Rice with stitching charges (excluding the cost of bag as the bags will be provided by PAPSCO to the successful tenderer); and
- ii) [50 Kg. \(net weight\) rice](#) in polypropylene bags [\(PP bags of supplier\)](#), which includes the cost of the PP bag;

and the rates quoted shall be inclusive of all duties, Cess, taxes, loading charges, transportation to the Fair Price Shops or any other places specified by PAPSCO, transit insurance, unloading charges at the specified places in Puducherry and Karaikal regions of the Union Territory of Puducherry.

r) the third para of PART-II OF PRICE BID at page 26 of 32 shall be read as follows;

The bidder shall quote rates for White colour Single Boiled Rice of common grade for different varieties like ADT-36, ADT-38, ADT-39, ADT-43, ADT-45, CHINNA PONNI, PUDUVAI PONNI, CO-43, CO-45, ADT-16, ADT-18, SORNA and such other fine variety or equal fine quality rice but not bold variety (free from stones, iron particles, broken rice, husk, bran, black rice, dis-coloured, damaged, unpolished rice, any other organic and inorganic foreign particles. The quoted varieties should be offered for both the regions. The Corporation does not guarantee any volume of quantity. However, supply order will be issued in the lots or consignments and the same is final and shall not be called into question.

s) Tabular coloumn at page 27 of 32 of PART-II OF PRICE BID shall be read as follows;

ELIGIBILITY CONDITIONS:

1. The tenderer, in case of rice millers, shall have an average monthly turnover of minimum Rs.3 Crores in rice trade during any of the last three years and in case of other than Rice Millers, the monthly turnover of minimum of Rs.3 Crores in overall trade including rice during any of the last three financial years. The tenderer other than Rice Miller shall be capable of trading the specified rice and required quantity. In this regard, a turn over certificate as per Annexure- IV and Balance Sheet and Profit & Loss Account along with Auditor's Report are required to be submitted.
2. The tenderer should be an Income Tax Assessee. In support of this, attested copy of Permanent Account Number (PAN) and latest Income Tax returns are required to be submitted.
3. The tenderer should not have been black listed or debarred for any default connected with handling of Essential Commodities/Rice from any Govt. Dept./Organization. An affidavit as per Annexure -V duly attested by the Oath Commissioner/Notary is required to be submitted in support thereof.
4. Any sister concern(s) of the tenderer applying against the same tender, would lead to disqualification of tenderer. Sister concern means a Company, Society, partnership firm or proprietorship having one or more common person as Director/Partner/member/owner.
5. Unregistered partnership firm shall not be eligible.

1. GENERAL

- a) Tenders should be filled duly furnishing the required information as per Tender document.

- g) Tenderers should be capable of supplying the ordered quantity of White colour Single Boiled Rice within 15 days from the date of acceptance of offer and delivery should start within 3 days of from the date of issue of supply order.

- i) Minors/insane are not eligible to file tenders.

11. PACKING:

- b) In case of supply in 10 Kg. **(net weight)** bags (bags provided by PAPSCO);

- i) the 10Kg. rice should be kept compactly and stitched in good manner without giving way to pilferage, damage of the bags till the specified delivery places. In case of any damage/loss of bag/rice, PAPSCO reserves every right to deduct necessary amount from the payments to be made to the supplier or to cancel the agreement and forfeit the Security Deposit/[invoking Bank Gurantee](#) besides black listing the tenderer.
- ii) The bags should be only of PAPSCO bag and the [labelling](#) if any on the bag should be as provided by PAPSCO and not of the bidder or other third parties. In case of any deviation in this regard, the Security Deposit of the tenderer will be forfeited besides blacklisting and the tenderer is only responsible for any consequences arising out the deviation.

13. FURNISHING INFORMATION

- a) Supplier shall obtain the details of quantity from M/s. PAPSCO, Puducherry for Puducherry and Karaikal.
- b) PAPSCO may undertake pre-dispatch inspection of stock by representative of its own office or any other Govt./Private Agency entrusted for that purpose at the premises where from the supplies are going to be made.

- c) Supplier shall furnish a daily report to the authorized Officer at the respective region on supply of stocks truck wise and destination wise quantity delivered through e-mail and Fax also.
- d) Supplier should maintain complete account of supplies made and also furnish the details as and when requested by the authorized Officer of the respective region.

14. ACCEPTANCE OF STOCKS

- a) Only the **white colour** SINGLE BOILED RICE of common grade of such variety selected in the tender only will be accepted. The stock should be free from stones, **iron particles**, broken rice, husk, bran, black rice, **dis-coloured, damaged, unpolished rice, any other organic and inorganic foreign particles.**
- b) Supplier should hand over three half-a-kg (1/2 Kg.) sample of the **White colour** Single Boiled Rice to be supplied in sealed covers at the respective Officer Incharges of PAPSCO at the Puducherry and Karaikal region on every consignment.
- c) At the time of delivery of stocks by the suppliers, the stocks may be subjected to quality check by the Quality Control Team/authorized representative of M/s. PAPSCO at the respective region at the loading point/goods in transit/unloading point, as the case may be. Samples will be drawn as per the usual procedure of PAPSCO in the presence of suppliers or their authorized representative. One sealed sample so drawn will also be given to the suppliers. In the event of supply of stocks not conforming to specifications, such stocks are liable for rejection. "The decision of the Quality Control Team/authorized representative at loading/**goods in transit/unloading points** will be final and should not be disputed"
- d) Supply shall be subjected to quality analysis and the PAPSCO at its discretion shall send samples of any consignment to the accredited or any other laboratory for analysis. In such cases, the result of accredited/lab is final.
- e) Stocks conforming to the specifications will only be accepted. Stocks not conforming to specifications stands summarily rejected and it is the responsibility of the supplier to take back the rejected stocks and replace the stock conforming

15. PENALTY ON DEFAULT/EXTENSION OF TIME

- a) The entire ordered quantity of **White colour** Single Boiled Rice should be supplied within the stipulated time. No extension of time will be granted for supply of beyond the specified date fixed.
- b) But in exceptional circumstances and if it is sufficiently proved that the delay in supply is due to the circumstances beyond the control of the suppliers, extension of time will be granted at the discretion of the Managing Director subject to the following conditions:
 - (i) A penalty of Rs.50/- (Rupees fifty only) will be imposed per Qtl. per day subject to a maximum of Rs.500/- per MT.  - (ii) If the supplier requires an extension of time for completion of the contractual supply, on account of occurrence of any hindrances, he shall apply in writing for extension on occurrence of hindrance but not after the stipulated date of completion of supply.
 - (iii) The Managing Director, PAPSCO may extend the delivery period with or without liquidity damage in case they are satisfied that the delay in the supply of goods are on account of hindrances beyond control, such reason shall be recorded while granting extension.
- c) Supply of stock less than the ordered quantity is not permitted. If the ordered quantity is not supplied in full, the Security Deposit will be forfeited/**Bank Guarantee will be invoked** besides blacklisting.
- d) In the event of failure to supply the ordered quantity by the successful tenderer within the stipulated time, the Managing Director reserves the right to cancel the orders for the unsupplied quantity and place orders with the remaining suppliers for the supply of the said quantity or purchase the unsupplied

quantity through limited tender system at the risk and cost of such supplier and the supplier is liable and responsible to make good the financial loss sustained by PAPSCO. If the rate in this case is cheaper the benefit will not accrue to the supplier.

- e) In the event of failure by the successful tenderer (L1), PAPSCO is at liberty and also reserves the right to purchase the ordered quantity from the next lowest tenderers (L2) to ensure uninterrupted supplies. In such circumstance, the differential cost, transport charges, incidental charges and other excess expenditure, if any, will be recovered from the successful tenderer (L1). If the rate is cheaper, the benefit will not accrue to the supplier.
- f) PAPSCO reserves the right to charge penalty as decided by the Managing Director of the Corporation or withhold payment for any unsatisfactory stocks supplied by the supplier without prejudices to other rights and the decision of the Managing Director is final and cannot be called into question. The supplier is liable to reimburse/compensate PAPSCO or to third party for any loss, damage, injury, etc caused or arising out of the negligence in supply of low or inferior quality of stocks or any breach of contract.
- g) Notwithstanding anything contained in the terms and conditions of this tender the Managing Director, PAPSCO is the ultimate authority in deciding the recovery of penalty from the supplier taking into account the stock position and future requirement of supply in the larger interest of PAPSCO.

16. FORCE MAJEURE

- a) In any of the force majeure circumstances, namely act of God, natural calamities, fire, Govt. of India's policy, Govt. of Puducherry's policy, any restriction imposed by State/Central Government (excluding any stock limits), strikes or lock out by workers, war, military operations of any nature and blockades preventing the Seller/Buyer, the performance of the contract shall be extended for as long as these circumstances prevail.
- b) In the event of the circumstances, if the continuation takes place for more than three months, the party can have the right to refuse its contractual obligations without title to indemnification of any losses which it may thereby sustain. The party which is unable to carry out its contractual obligations shall immediately

advise the other party of the commencement and the termination of the circumstances preventing the performance of the contract.

17. BLACKLISTING AND RECOVERY OF LOSSES

- a) In the event of failure by the tenderers at any stage of tender process the Earnest Money Deposit or Security Deposit or Bills of supply will be forfeited apart from cancellation of award of contract and blacklisting.
- b) If it comes to know that the tenderer selected is already blacklisted and not eligible at the time of this tender, the selected tenderers agreement will be cancelled besides forfeiture of Security Deposit, black listing and recovery of consequential losses, if any, sustained by the Corporation on calling of another tender, etc. as the case may be.

18. PAYMENT

- a) The payment of cost at the rate accepted will be made to the supplier for a net quantity of White colour Single Boiled Rice supplied within 30 days on submission of the bills in triplicate, along with acknowledgement(s) obtained from the Official Incharge of the Fair Price Shops or any other places/units specified by PAPSCO at the unloading point at the respective region along with quality certification and advanced stamp receipt duly verified by the Officer Incharge of PAPSCO at the respective region. In case, the suppliers require demand draft, the same will be issued after deducting Bank charges.
- b) The payments will be made by M/s. PAPSCO, Puducherry for both regions.
- c) Payment of interest on late payment of bills etc., will not be acceptable to PAPSCO.
- d) No advance payment of any kind for the supply of White colour Single Boiled Rice will be made to the bidder.

19. SUB-LETING: The supply contract awarded should be executed by the successful tenderers only and sub-letting any of the functions under the contract is not permitted.

20. INDEMNITY: The tenderers shall indemnify the Corporation against all claims which may arise in supply of inferior and low quality of White colour Single Boiled Rice.
