3. Functions of the Committees:

The Vigilance Committees are to check whether the Targeted Public Distribution System (TPDS) schemes are implemented properly and to conduct spot inspection / verification and to submit report to the Government, based on the complaints received from the General Public for the above purpose.

(i) The State / District level committees shall regularly supervise the implementation of all schemes under the Food Security Act, 2013 and inform, in writing any violation of the provisions of this Act and any malpractice or misappropriation of funds found by it, to the District Grievance Redressal Officers of respective region as per the Order G.O.Ms.No.07 dated 07.08.2015 of the Department of Civil Supplies and Consumer Affairs, Puducherry .

4. The Committees will meet as and when necessity arises, but not less than once in every quarter at both the levels as prescribed under the TPDS (Control Order) 2015.
